5. The Funds are not available for diversion/re-appropriation.
6. The utilization certificate/ Red Accounts of the funds released shall be furnished to the concerned quarters including Accountant general, J&K.
7. The Secretary, J&K State Sports Council shall furnish monthly object wise expenditure statement to the Administrative Department.
