5. that the Executing Agency shall take up the work only after the DPRs are formulated and Technical Sanction accorded by the Competent Authority.
6. all Administrative Approvals /Technical Sanctions are in place before incurring the expenditure
7. that the concerned Drawing and Disbursing Officer shall vouchsafe the availability of funds under Capex Budget 2018-19 (Grant -in- Aid)
8. that the UCs of pervious advance and this advance shall not only be submitted but invariably furnished for record and reference.
