4. The audited statements shall be furnished by the Secretary, J&K State Sports Council to the Youth Services & Sports Department along with utilization certificate in respect of the funds released.
5. The Secretary, J&K State Sports Council shall furnish monthly object wise expenditure statement to the Administrative Department.
6. Utilization Certificate along with account of expenditure may be submitted to the Accountant General, J&K Srinagar/Jammu for the year 2017-18.
