Sanction is hereby accorded to the temporary appointment of Shri Kushvinder Kumar S/o Late Shri Krishan Chand(Ex-Junior Assistant) R/o Bhaddu Tehsil Billawar District Kathua, as Class-IV (Groundsman), in the Pay Band of Rs. 4440-7440 with Grade pay of Rs. 1300/- in Youth Services and Sports Department in District Cadre Kathua in relaxation of the prescribed qualification in terms of Rule 7 of SRO-43 of 1994.

The appointee shall report to the Director General Youth Services and Sports within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Age and Health Certificate.
- iii. Permanent Resident Certificate.
- iv. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- v. Any other relevant documents as are required under SRO-43/1994.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointee shall be initially on probation for a period of two years, if, on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand as cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Director General Youth Services and Sports.
