5. the funds released under the Object Heads Ongoing/New Works and Maintenance and Repairs shall not be utilized till the works Programme is not finalized and approved by the Competent Authority.
6. the Priority shall be assigned to the works /projects which are in advance stage of completion ,so that such projects are completed and handed over to the user agency in time.
7. in case of other ongoing projects where a sizeable investment is required , funding shall be made available commensurating with the progress of the work.
8. the works Plan under Capex Budget 2018-19 be furnished to the Administrative Department within 02 days positively as per the devised format already forwarded to you vide this department letter No.TE/Plan/AP/YSS/256/2018 dated.22-6-2018 for discussion /approval of the authorities.


