Sanction is hereby accorded to the release of additionality amounting to Rs.500.00 Lakh (Rupees Five Crore only) through BEAMS in favour of Director General, Youth Services and Sports, J&K under Detail Head 0364 Wages (Outsourcing) for meeting the requirement of NYC's for the financial year 2018-19 with the following conditions:-

1. That the DDO shall ensure that the allotment is not exceeded in any case.
2. That The additionality has been authorized under detailed Head '0364 Wages (Outsourcing) for making payment of wages to 6069 NYCs re-engaged in the Department in terms of SRO 520 of 2017 dated 21-12-2017 @ Rs.2500 per Month.
3. That the Director General, Youth Services and Sports shall seek an undertaking from all such workers that they shall not claim for enhancement of their wages till regularization under SRO-520.
4. The Director General, Youth Services and Sports is also requested to provide the actual date of re-engagement of all these NYCs alongwith the actual requirement of funds for the current financial year @ Rs.2500 per Month.
5. All financial rules/orders and instructions issued by the Government from time to time shall be observed while incurring the expenditure against allocated amount.


