Pursuant to the recommendation of the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of Shri. Amir Hassan S/o Sh. Ghulam Hassan Ganie R/o Dangerpora Chitragam, District Shopian against the post of Class-IV (Mali), Divisional Cadre, Kashmir, carrying the Pay Level-SL1 (14800-47100) with immediate effect.

The appointment shall be subject to the following conditions:-

i) That the appointee shall report to the Director Youth Services & Sports, J&K, within a period of 21 days alongwith all original certificates. In case the appointee does not join within the said period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.

ii) That the appointee, if already in service/otherwise, shall give an undertaking in the shape of an affidavit to the effect that:-

a) If on verification, the qualification certificate(s)/reserved category certificate/experience certificate etc. (where ever/whichever applicable) is found forged, false or fake by the concerned issuing authorities, the appointee shall have no claim for appointment and his services shall be deemed to have been terminated/cancelled ab-initio.

b) That the salary of the appointee shall not be drawn and disbursed to him unless and until the satisfactory report/genulneness of the certificates in respect of (ii) (a) above is received.

- c) That the cadre allocated by the appointing authority /JKSSB shall not be changed under any circumstances by any authority/department/HOD/Officer.
- d) That the appointment shall be deemed cancelled/cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on and he shall also be liable for criminal prosecution.
- iii) That the appointee shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. No 192 of 2020 dated 17.06.2020.
- iv) That if by any chance, candidate who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he/she will be liable for cancellation of selection ab-initio and criminal prosecution as well in light of the judgment rendered by the Hon'ble Supreme Court.
- v) That the inter-se seniority of the appointee shall be as per the merit as it exists in the select list.
- vi) That the appointment shall be subject to outcome of the writ petition/OA, if any pending in any competent Court/Tribunal on the subject.
- vii) That the appointee shall furnish an undertaking as per the prescribed format.


