2. All the codal formalities are required to be completed.
3. All financial rules/orders and instructions issued by the Government from time to time shall be observed while incurring the expenditure against allocated amount.
4. The detailed Red Accounts shall be rendered to Accountant General within stipulated time
5. Any saving out of the advance drawal occurring due to reduction of number of days/participants keeping in view the actual expenditure in

accordance with the admissibility or any other reasons shall be refunded to the Government account.

6. Reasonability / Genuineness of rates shall be ascertained.
7. No diversion of funds shall be made.
8. It shall be ensured that all accounts shall be maintained as per the codal procedures in vogue.

The expenditure on this account shall be debitable to Major Head: 2204-YS&S, Detailed Head: 022-Camps, Seminars & Conferences (Non-Plan) for the year 2023-24.


