The appointment shall be subject to the following conditions:-

- I. That the appointees shall report in the Directorate of Youth Services and Sports J&K, within a period of 21 days alongwith all original certificates. In case the appointees does not join within the said period, their appointment shall be deemed to have been cancelled ab-initio without any further notice;
- II. That the appointees, if already in service/otherwise, shall give an undertaking in the shape of an affidavit to the effect that:



- a. if on verification, the qualification certificate(s)/reserved certificate/experience certificate etc. (wherever/whichever applicable) is found forged, false or fake by the concerned issuing authorities, the appointees shall have no claim for appointment and his/her service shall be deemed to have been terminated/cancelled abi-intio. Further his/her appointment shall be subject to the final verification of Character and antecedents from the CID in terms of Government Order No.528-JK(GAD) of 2021 dated 21.06.2021, as amended from time to time.
- b. That the salary of the appointees shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificates in respect of (ii) (a) above is received;
- c. That the cadre allocated by the appointing authority/ J&K SSB shall not be changed under any circumstances by any authority/department/HoD/Officer.
- d. That the appointment shall be deemed cancelled/cancelled abi-intio, if it is found that the candidates is having higher qualification then the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- III. That if by any chance candidates who is not eligible for the post manages to secure selection by way of misrepresentation of false information and it comes to notice at a later stage, he/she will be liable for cancellation of selection abi-intio and criminal prosecution as well in light of the Judgment rendered by the Hon'ble Supreme Court.
- IV. That the inter-se seniority of the appointees shall be as per the merit as it exists in the select list;
- V. That the appointment shall be subject to outcome of the writ petition/OA, if any pending in any competent Court/Tribunal on the subject; and
- VI. That the appointees shall furnish an undertaking as per the enclosed format.
