
Sanction is hereby accorded to the constitution of a Sub-Committee to scrutinize the applications received in the J&K Sports Council from the candidates and draft a proposal for submission to the Committee to be constituted by the General Administration Department for appointment of outstanding sports persons in terms of provisions of S.O 12 of 2022 dated 06.01.2022, consisting of the following officers :-

1. Smt. Nuzhat Gul, Secretary J&K Sports Council-Chairperson of the committee.
2. Sh. Bashir Ahmad Bhat, JKAS Joint Secretary, J&K Sports Council- Member.
3. Sh. Bashir Ahmand, Joint Director, Kashmir, Directorate of YSS-Member.
4. Sh. Mohammad Ayub Dar, Under Secretary to Government, YSS Department-Member.

The Chairperson may invite other representatives, as may be required, as special invitees. The terms of reference of the committee shall be as under:-

- i) To frame the proposal for the committee vis-à-vis the year for which the candidate has opted, and the available Gazetted/Non- Gazetted vacancy, as the case may be.
- ii) To determine the sports merit, as prescribed under Rule (7), along with Annexure-II to S.O. 12 of 2022 dated 06.01.2022, to place the candidates in order of the points secured by them.
- iii. To make clear mention in the proposal for considering the appointment of those candidates who could not be considered for the period 2014-21, in the year 2022 only, if they full-fill the eligibility criteria laid out under the ibid S.O so that year-wise allotment of posts vis-à- vis applicants can be examined in terms of provision of Sub-Rule(iii) of Rule(10) of S.O. 12 of 2022 dated 06.01.2022.
- iv) If any of the candidates require relaxation in age/other qualifications/criteria of eligibility, clear mention needs to be made of the same for further examination in GAD along those lines. The Committee shall submit its report/proposal within a week's time positively.
