1. 2. That the Station Permission so granted shall be valid only subject to outcome of a satisfactory report on account of obtaining necessary security clearance and other clearances related to the Individuals facing investigation / inquiry on serious charges, who may try to evade apprehension by police authorities, or facing the inquiry.
3. That the leave whatsoever due in accordance with the rules shall be sanctioned by the competent authority delegated with the powers under Jammu and Kashmir Leave Rules,1979 only after verification of title of such leave in accordance with rules/norms governing such matters and only after fulfillment of above two conditions by the Director, YSS at the Directorate level.
