The Institutes where the appointees are presently working shall allow them to join formally on the post on which they have been regularized after checking/verifying the following certificates in original:-

- i. Date of Birth Certificates.
- ii. Permanent Resident Certificate (PRC).
- iii. Academic Qualification Certificate.
- iv. Technical Qualification (where required).

If on verification, the certificates produced by the appointees proved fake or forged, their appointments shall be deemed to have been cancelled ab-initio.
