In continuation to Government order No.123 Edu(Tech) of 2017 dated.14-12-2017, sanction is hereby accorded to the **release of further revalidated amount of Rs.18.00 lacs (Rupees Eighteen lacs only) under the Centrally Sponsored Scheme “Externally Aided Project for Reforms and Improvement in Vocational Training Services rendered by the Central & State Governments (VTIP)”** with the World Bank Assistance for **setting-up of Centre of Excellence/Up-gradation of Trades** in ITIs in favour of Director Technical Education Department for its utilization, during current financial year 2017-18.

2. the Department shall submit a status report about the scheme, in terms of physical and financial progress made during the current financial year and upto date cumulative expenditure and physical achievement.
3. the Department shall report the utilization of funds released as early as possible and definitely well before 31-03-2018 to the Administrative Department for onward transmission to concerned Ministry.
4. the concerned Drawing Officer shall vouchsafe the utilization of funds as per codal procedure/Govt. of India's guidelines.
5. all the codal formalities be observed before incurring the expenditure such as AAA/Technical Sanction etc..
6. the funds so authorized shall not be available for re-appropriation for any reason whatsoever.
