2. The audited statement shall be furnished by the Secretary, State Board of Technical Education to the Technical Education Department along with utilization certificate in respect of the funds released earlier.
3. The Secretary, State Board of Technical Education shall furnish object wise expenditure statement to the Technical Education department.
4. Utilization Certificate along with account of expenditure may be submitted to the Accountant General, J&K Srinagar/Jammu.
5. The Next installment shall be released only on receipt of utilization certificate of previous installment from the Secretary, State Board of Technical Education.
