Sanction is hereby accorded to the release of additional funds amounting to Rs.75.00 lacs (Rupees Seventy Five lacs Only) under Capex Budget 2016-17 in favour of Director, Youth Services & Sports Department J&K, for meeting the expenditure on account of the Construction of 22 number of Volley ball courts (one in each District) during current financial year 2017-18.

The release shall be subject to the following conditions that;

1. all codal formalities be observed before incurring of the expenditure.

3. the concerned DDO shall vouchsafe the utilization of funds as per codal procedure.
4. the works shall be executed after obtaining AAA/TS and adherence of all other codal formalities
5. all the necessary clearances /approvals shall be sought from the competent authorities before implementation of the scheme.
6. the department shall ensure the reasonability of rates and complete the project within the approved cost only.
7. there shall be no cost /timeover run .
8. there shall be no overleaping of funding from any other source.
9. the funds so released shall not be available for re-appropriation/diversion at any level.
10. there shall be no expenditure on Revune or Reveue like items.
11. the expenditure shall be incurred only on fresh works ,and shall not be used to clear any previous liability.
