3. that diversion of funds shall not be admissible.
4. that the status of Utilization of funds, both on Physical and Financial parameters & Red accounts , shall be submitted to the YSS Department on 5th of every succeeding month.
5. that the Executing Agency shall take up the works only after AAA & Technical Sanctions are accorded by the Competent Authority.
6. that the utilization certificates in respect of Grant-in-Aid for the year 2017-18, shall be submitted to the YSS Department by or before 31st March 2018.
7. that the concerned Drawing and Disbursing Officer shall vouchsafe the availability of funds under Capex Budget for the purpose.
8. That there shall be no cost /time over run .
9. That there shall be no overriapping of funding from any other sources.
