Sanction is hereby accorded to the release of additional funds amounting to Rs.2.78 lacs (Rupees Two lac and Seventy Eight thousand only) under Capex Budget 2017-18 in favour of District Development Commissioner, Shopian as land/tree compensation for fruit trees identified for construction of Multipurpose Indoor Sports Hall at Arhama Shopian under PMDP.

**The releases of funds shall be subject to the following conditions that;**

- i. the District Development Commissioner, Shopian, shall verify and ensure that the payment is made strictly as per the Land Acquisition Act and /or other relevant Act/rules governing such cases in particular proof of ownership and eligibility conditions to be well established before making any payments.
- ii. the funds so released shall be utilized only for specific purpose after observing all codal formalities.
- iii. there shall be no overlapping of funds from any other source.
- iv. the funds so released shall not be available for re-appropriation/diversion at any level.
- v. the trees are removed and land is made available to this department free of encumbrances for construction of Multipurpose Indoor Sports Hall.
- vi. the expenditure shall be booked under proper classification.
- vii. no further liability is created on account of acquisition.
