Subject: Accord of Administrative Approval in respect of Development of Playfield by way of Synthetic Football Turf at Draggod Shopian

Government Order no. 51 JK(YSS) of 2023
Dated 2-11-2023

In pursuance of S.O 15 dated 09.01.2020, Administrative Approval is hereby accorded for Development of Playfield by way of Synthetic Football Turf at Draggod Shopian at a cost of Rs.580.00 Lakhs (Rupees Five crores and eighty lacs Only) through Construction Division, J&K Sports Council Srinagar. The Accord of Administrative Approval is subject to the fulfillment of following conditions:

1. That the proposals shall be strictly devised and designed as per the latest relevant I.S codes and specifications of PWD/CPWD and same is authenticated and proof checked by the competent authority (NIT/DIQC/IIT), before taking up execution in hand.
2. That the Electrical/Mechanical/Electronic components are authenticated and technically vetted by the competent authorities of relevant field.
3. That the standard specifications are followed as per CPWD, NBC and I.S standard.
4. That the specifications as defined in CPWD PLINTH AREA RATE SCHEDULE for the type of structure proposed in the DPR, are followed and adopted for the execution of the works.
5. That the rates for the items, not covered in JKSSR or any other relevant Schedule, shall conform to analysis of rates based on authentic Data Book, to be computed and approved by the Competent Authority well before invitation of tenders in accordance with set codal procedures.
6. That the lump-sum provisions, either in terms of percentage or fixed, as made for certain components in the DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by Competent Authorities well before invitation of tenders in accordance with set codal procedures.
7. That the working BOQs, based on approved design details/requirements are framed as per J&K PWD Schedule of rates for e-tendering purpose of each Project.
8. That e-tendering mode is followed for fixation of the award of contract for execution of the Project. Fragmentation of Project, while tendering, is not allowed.
9. The Technical Vetting is exclusively for the purpose of Accord of Administrative Approval and shall not be construed as any rate approval to the projects or any approval for inclusion in the plan.
