1. No new or additional Abstract Contingent Bill shall be drawn until a certificate is obtained from Accountant General (A&E), confirming that the accounts for the

previous advance drawal have been rendered in accordance with the circular issued by Finance Department under endorsement No. DGAT/PS/DR/T-AdoMisc/42/2021-01/273 dated 12-09-2022.

2. Funds must be utilized in full compliance with the General Financial Rules (GFRs) and other applicable codal provisions.
3. A transparent e-tendering process through GeM must be followed in both letter and spirit.
4. Expenditures shall be made only for items that have been specifically approved by the Competent Authority.
5. Funds should not be withdrawn merely to be parked in a bank account; they must be utilized for their intended purpose.
6. Necessary approval for expenditure must be obtained from the Competent Authority before incurring any costs.
7. A detailed expenditure report, in the form of red account report, must be submitted to the relevant authorities, with copies sent to the Finance Department.
8. Funds must be used exclusively for the activities outlined in the provisions.
9. The expenditure on this account shall be debitible to Major Head: 2204-YS&S, Detailed Head: 022-Camps, Seminars & Conferences (Non-Plan) for the year 2024-25.
