2. The accounts of the Association shall be open to check by the Accountant General, J&K /Finance Department as well as the officers of Youth Services & Sports Department at any time.
3. The audited statement shall be furnished by Bharat Scouts & Guides Association to the Youth Services & Sports Department.
4. Utilization Certificate shall be submitted to the Accountant General, J&K/ Finance Department & Youth Services & Sports Department by the Association with in stipulated time.
5. Any saving out of the advance drawal keeping in view the actual expenditure shall be refunded to the Government account.


