Pursuant to the recommendation of the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of following candidates as Junior Assistant (State Cadre) in the Directorate of Youth Services and Sports, J&K in the Pay Level-SL4 (25500-81100) with immediate effect:-

The appointees shall report to the Directorate of Youth Services & Sports, J&K, within a period of twenty one (21) days from the date of issuance of this order and such candidates who fail to join within the stipulated time, shall forgo their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of following certificates (in original) to be verified subsequently:-

- i. Academic/Technical Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate issued by the Chief Medical Officer.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under any self employment scheme has been availed by the appointee.
- vi. Valid relevant Category Certificate, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

- a. Each appointee shall give an undertaking in the shape of an Affidavit to the effect that if on verification, his qualification/Date of Birth and Reserved Category Certificates from the concerned issuing authorities found fake/forged his appointment as Junior Assistant shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of genuineness of qualification/Date of birth and relevant Category Certificates is received from the concerned authorities/agency.
- c. The appointment of the candidates shall be governed in terms of Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020.
- d. The inter-se-seniority of the appointees shall be determined as per the merit as it exists in the select list.
- e. The appointment of the above candidates shall be subject to outcome of the writ petition(s), if any, pending before competent Court of law.
