Whereas, J&K Public Service Commission vide reference No. PSC/DR/YS&S/2022 dated 28.6.2023 has forwarded the selection list of 19 candidates for the post of Physical Education Lecturer in J&K Youth Services and Sports Department for their appointment as Physical Education Lecturer;

Whereas, the selected candidates were appointed in the Youth Services and Sports Department vide Government Order No.45-JK (YSS) of 2023 Dated:- 12-10-2023 and Government Order No. 48-JK(YSS) of 2023 dated: 02.11.2023;

Whereas, in the meanwhile the petitioner namely Tarvinderpal Singh filed the above subject OA before the Hon'ble Tribunal challenging the selection of private respondent namely Shail Sharma and his ousting from the selection list. The Hon'ble Tribunal vide order dated 24.07.2023 has directed that the appointment letter shall wait till the next date of hearing qua respondent No. 3 (Sahil Sharma S/o Shakti Sharma).

Whereas, the Youth Services and Sports Department has issued the appointment order, among others selectees, in favour of the petitioner vide Government Order No.45-JK (YSS) of 2023 Dated:- 12-10-2023.

Whereas the petitioner, Tarvinderpal Singh , has filed another OA before the Hon'ble CAT for his appointment against the PSP category. The Hon'ble Tribunal vide order dated: 22.05.2024 has passed following order:-

"Vide order dated 24.07.2023, this Tribunal passed detailed order, where one post of Physical Education Lecturer was kept reserved for the applicant. Thereafter, again the order is stayed vide order dated 02.02.2024, where Mr. Rajesh Thapa, learned AAG stated that no person has been appointed in place of the applicant.

As per averments made by learned counsel for the applicant, the respondent no. 3, namely, Sahil Sharma has been appointed by the

respondent department despite of the two earlier orders dated 24.07.2024 and 02.02.2024 passed by this Tribunal, which is in violation of the court's orders. So, this order is stayed, qua, the respondent no. 3."

Process would remain continue for the rest till next date of hearing. In the meanwhile, respondents are directed to file the reply.

Now, therefore, in view of the position explained above and since the order of appointment has been stayed by the Hon'ble Tribunal, the appointment made vide Government Order No. 45-JK (YSS) of 2023 Dated: - 12-10-2023 (Sr. No. 1 in PSP Category) in favour of Respondent No. 3, Mr. Sahil Sharma S/o Mr. Shakti Sharma R/o 115 Moh, Suthra Bawli Ward No. Fifteen Haveli is hereby kept in abeyance with immediate effect till the final outcome of OA or till the vacation/ modification of interim order dated 22.05.2024.


