In continuation to Government Order No. 18-JK (YSS) of 2022 dated 06-06-2022 and Government Order No. 02-JK(SS) of 2023 dated 02-01-2023, sanction is hereby accorded to the:-

1. Authorization for release of further funds amounting to Rs. 05.00 lakhs (Rupees Five Lakhs Only) by Director, Youth Services & Sports J&K in favour of Bharat Scouts & Guides out of funds available under Detailed Head 022-Camps, Seminars & Conferences (Revenue Budget).
2. Advance drawl of said amount by Accounts Officer, Directorate of Youth Services & Sports J&K for further placement with Bharat Scouts & Guides Association.

The authorization/advance drawl shall be subject to the following conditions:-

1. Accounts Officer, Directorate of Youth Services & Sports J&K shall not draw any fresh Abstract Contingent Bill until a certificate is enclosed from Accountant General (A&E) on the bills that the accounts of previous advance have been rendered to the Accountant General (A&E) as per circular issued by Finance Department under endorsement No. DGAT/PS/DR/T-Ad0Misc/42/2021-01/273 dated 12-09-2022.
2. All the codal formalities are required to be completed.
3. All financial rules/orders and instructions issued by the Government from time to time shall be observed while incurring the expenditure against allocated amount.
4. The detailed Red Accounts shall be rendered to Accountant General within stipulated time.
5. Any saving out of the advance drawal occurring due to reduction of number of days/participants keeping in view the actual expenditure in accordance with the admissibility or any other reasons shall be refunded to the Government account.
6. Reasonability / Genuineness of rates shall be ascertained.
7. No diversion of funds shall be made.
