NOTIFICATION

- i. Whereas, 126 applications on prescribed format were received by the J&K Sports Council in response to the notifications issued under endorsement No: - SC/491-UG-NEET/7396-7406, dated: 6-10-2021 for grant of sports category weightage to claim benefit for admission in UG-NEET Courses 2021 (MBBS/BDS/BAMS/BUMS/BPT) in Govt. run institutions under sports quota; and
- ii. Whereas, the applications were scrutinized on 25-11-2021 by the committee constituted for the purpose under Govt. Order No: - 808-GAD of 2008, dated: - 17-06-2008 read with Govt. Order No: - 590-GAD of 2018 dated: - 11-04-2018 in terms of criteria in vogue and terms and conditions laid down in the notifications issued for the purpose; and
- iii. Whereas, the Seventy nine candidates figuring at Serial Nos. 2,3,4,5,6,8,10,11,13,14,16,17,18,20,22,26,28,29,30,31,32,33,40,44,48,49,50,51,52,54,55,59,60,61,62,63,64,65,69,70,71,72,73,74,76,77,79,82,83,84,87,88,89,90,92,93,95,96,98,99,102,104,105,106,107,108,109,110,112,114,115,116,118,119,120,121,122,125,126, as per the list Annexed herewith as Annexure 'A' of this notification have been found eligible by the committee and points awarded to their sports achievements as mentioned against each; and
- iv. Whereas, the committee has also found forty three candidates eligible figuring at serial nos, 1,7,9,12,19,21,23,24,25,27,34,35,36,37,38,39,41,42,43,45,46,47, 53,56,57,58,66,67,68,75,78,80,81,85,86,91,94,97,101,111,113,117, & 124 and awarded sports points to their sports achievements as mentioned against each subject to verification of their certificates from respective recognized National Sports federations/DYSS/SAI within a period of One week from the date of issuance of this notice. The candidates shall also follow the concerned quarters for early response; and
- v. Whereas, three candidates figuring at serial nos. 15,104 & 123 of the list as per annexure -A have withdrawn their applications and same was noted by the committee; and
- vi. Whereas, one Candidate figuring at serial no. 100 of the list as per annexure-A has not been found eligible by the committee due to the reason that Tennis Cricket discipline is not covered under rules; and

- vii. Whereas the committee examined the representation of Mr Dishal Thakur S/o Raghubir Singh R/o Village Harichuma Tehsil Toryath District Rajouri in terms of interim order passed by the Hon'ble High Court of J&K Srinagar Bench on 22-10-2021 under WP(c) No.2303/2021 CM No.8158/2021 and considered the same in accordance with rules & regulations applicable to the field. The committee observed that petitioner is short of requisite qualification required for consideration of sports category and as such the applicant is not eligible to claim benefit under sports category. Hence the representation has been found devoid of merit & rejected; and
- viii. Whereas, the committee further examined the writ petition of Mr Parvaiz Mustafa S/o Ghulam Mustafa Wani R/o Bathindi, Jammu in terms of interim order passed by the Hon'ble High Court of J&K Jammu Bench on 24-11-2021 under WP (c) No.2543/2021 CM No.8786/2021 and considered the same in accordance with rules & regulations applicable to the field. The committee observed that petitioner is in possession of requisite qualification required for consideration of sports category and as such the applicant is eligible to claim benefit under sports category. Hence the petitioner has been found eligible by the committee having twice participation at National level in Kho Kho discipline duly verified by Directorate of YSS & allotted one point subject to completion of requisite formalities; and
- ix. Whereas, the committee has also recommended to conduct Physical Verification Test/Viva of the eligible candidates at Srinagar/Jammu to ascertain the proficiency of the game/sports opted by the candidate; and
- x. Whereas, the committee also recommended that applicants should be asked to submit track record of lower level competitions/domestic activities during the physical verification test/viva to ascertain the genuineness of the participation in National events; and

In view of the above, objections/grievances if any with regard to eligibility of the candidates or otherwise including points allotted/observations to their sports achievements made by the committee are, therefore, invited which should reach to this office at Sports House, M.A. Stadium Jammu on or before 07-12-2021 during office hours in hard and soft copy. Soft copy can be emailed on jkstatesportscouncil@gmail.com. Objections/grievances received after the prescribed date shall not be entertained. The decision of the committee shall be final in such matters.

The eligible candidates shall report to Sports Officer (K), J&K Sports Council, Polo Ground, Playing Field, Srinagar and Sports Officer (J), J&K Sports Council, New Indoor Sports Complex, M.A. Stadium, Jammu alongwith track record and proper identification proof on 06-12-2021
