- i. Whereas, 17 applications on prescribed format were received by the J&K Sports Council in response to the notifications dated dated 7-9-2021, 8-9-2021, 10-9-2021, and 28-10-2021 for grant of sports category weightage to claim benefit under various professional courses under sports quota; and
- ii. Whereas, the applications were scrutinized on 25-10-2021 by the committee constituted for the purpose under Govt. Order No: - 808-GAD of 2008, dated:- 17-06-2008 read with Govt. Order No: - 590-GAD of 2018 dated:- 11-04-2018 in terms of criteria in vogue and list of eligible candidates was notified on 29-10-2021 in Print and Social Media which includes Official Website of J&K Sports Council; and
- iii. Whereas, one representation on plain paper from Mr Wasik Rashid Magray S/o Abdul Rashid Magray R/o Odura Kulgam received on 01-11-2021 who could not apply within the due date was accepted by the committee in its meeting held on 17-11-2021 as per the interim directions of the Hon'ble High Court of J&K and Ladakh Srinagar Bench passed on 10-11-2021 under WP(C) 2301/2021CM No 7431/2021; and
- iv. Whereas the committee has found Mr Wasik Rashid Magray eligible under rules and awarded 1 point for his twice participation at National level in Atya Patyal discipline subject to verification of his certificates from Atya Patya Federation of India and appearance in Physical Verification Test/Viva including completion of required formalities;and
- v. Whereas, the committee examined physical verification test/viva reports forwarded by the respective Sports Officers of J&K Sports Council and noted that candidates named below remained absent during physical verification test/viva and accordingly dropped their eligibility /candidatures:-


